Teen Dating Violence Awareness Month: Moving from Terror to Hope & Healing



February is Teen Dating Violence Awareness Month, which always makes me sad. When I think of teens, I conjure up positive images of school, college applications, music and fashion, earning a driver's license, crazy fun with friends, mood swings, that first crush, and steady growth into independence and adulthood - NOT violence and fear. However, for many teens, dating violence is a terrifying reality.

The statistics are staggering. According to Love Is Respect, the National Teen Dating Violence Helpline, 1.5 million high school students experience physical abuse from a dating partner every year. One in three adolescents in the U. S. is a victim of physical, sexual, emotional or verbal abuse from a dating partner. Use of technology to coerce, stalk, and blackmail teen partners is increasingly common in abusive teen relationships. Girls and young women between the ages of 16 and 24 experience the highest rates of intimate partner violence - almost triple the national average. Victims of teen dating violence are at higher risk for substance abuse, eating disorders, risky sexual behavior, pregnancy, sexually transmitted infections, additional domestic violence, and suicide, compared to girls and boys who are not abused. Tragically, most teens who experience intimate partner violence

Letter from the Executive Director of Dove, Inc.:

Coordinating Efforts to Address Unmet Needs and Social Injustices.

Dear Friends,

What are today's unmet needs? This is a question we hope to constantly ask and act on here at Dove, Inc. This month I'd like to highlight the grim reality of human trafficking in our community. Human Trafficking is the use of force, fraud, or coercion to obtain something of commercial value such as housing, labor, or commercial sex act. Locally we see examples every day in our various programs. Individuals are coerced into panhandling, drug sales, giving up their link or medical cards, having their credit used and damaged.

Many people think of trafficking as moving people far away in order to exploit them, in reality most people locally are trafficked in the same neighborhoods they grew up in, or within a few miles. Trafficking is exploitation and does not require movement across city, county, state or national borders. What it does require is the use of power and control. In short Human Trafficking is one form of Domestic Violence.

Dove is working through our many programs to help victims of exploitation. We are reaching out to help victims know that our resources are here to help. We are connecting those who come forward with confidential services including counseling, housing options, shelter, financial and legal assistance. We are advocating in the community for additional housing units so there is never a person who feels that they have no other option. We are sending the message, "You are not alone, you do not have to live like this, we can help."

If you or anyone you know is being exploited, I urge you to help them either contact Dove through our Domestic Violence Program 217.423.2238 or reach out to Homeward Bound 217.362.7700, after hours 217.619.5742 to connect to the Macon County Coordinated Entry System for housing resources. Dove, Inc. is only as strong as its member organizations, volunteers, and advocates. It is my sincere hope that you will be a part of making our home a community free of human trafficking.

never tell anyone – only 33% tell a family member or friend. Parents and friends might see warning signs of abuse, but often feel helpless to protect the teen.

The good news is that Dove Domestic Violence Program offers help and hope to teen dating violence victims and their families. Dove provides prevention education in schools throughout DeWitt, Macon, Moultrie, Piatt, and Shelby counties, reaching teens with information on healthy relationships, teaching them the warning signs of an abuser, and informing them of their legal rights and of how to get help for themselves or a friend. Dove provides crisis intervention for teens in abusive relationships, including assistance with orders of protection. (In Illinois, an adult may seek an order of protection on behalf of a minor under the age of 18. In most teen dating violence cases, parents or guardians seek the OP on behalf of their teen.) Individual and family counseling is available to help teens and their parents do safety planning and cope with the danger, emotional trauma, and family disruption that occurs during and after an abusive relationship. Dove's hotline is the best way to access or inquire about services, 423.2238. The hotline and all other Dove services are completely confidential.

There are simple things we all can do to address teen dating violence:

- If you are a parent, model a loving and respectful relationship at home – your children and teens are watching and learning from you. Talk to your teens about important issues and let them know that you are always there when they need to talk. If your teen comes to you with relationship concerns, take them seriously – abusive teen relationships can be dangerous. If your daughter or son is being abused, believe her/him, know that this is not your teen's fault, and seek help - contact Dove's hotline, 423.2238. Dove staff can discuss options with you and assist with orders of protection, counseling, and other services. (If the situation is an emergency, call 911 first and contact Dove for follow-up assistance.)
- If you are a teen whose partner is abusive, TELL SOMEONE! Make sure your friends know what is happening, but more importantly, tell a trusted adult, like Mom or Dad, a counselor or favorite teacher at school – someone who can seek help for you. You deserve to be treated with respect – an abusive relationship is not your fault and is never acceptable!
- If you are a concerned friend or relative, talk to the teen.


Although your offer of help may be rejected at first, you have planted a seed of information and hope; the teen may reach out to you later for help.

Teen dating violence is something that no teen should experience. However, Dove's prevention education and crisis intervention services ensure that information, help, hope, and healing are available for all teens.

New Opportunities for our Domestic Violence Clients

We have exciting news from the Domestic Violence Program! We are happy to announce that we will be having more of a regular presence in Piatt County! We are in the process of securing office space so we can go back to having a full time office in Monticello! It's been many years (approximately 15) since we last had an office there!!

Janisha Pealer, our Multi-County Advocate, will staff the office. We are looking forward to providing services there again and working with all the other agencies, organizations and key officials in Piatt County in providing services to victims of domestic violence! We will keep you posted!

In addition, the Decatur office will soon be offering additional groups to our clients. In addition to our current two domestic violence support groups, Parenting Group, weekly Bible Study Class, and Lifeskills Group, we will be adding:

- **Legal Groups – Starting Monday, February 5. Jamie Houchins will lead a group from 1:00 to 2:00 p.m. and Vivian Reed will lead the an evening group from 6:00 to 7:00 p.m. This group will focus on legal options for victims of domestic violence, including orders of protection, court process, remedies, and other laws that benefit victims.**
- **The Golden Doves Elder Group – Kathy Walters will facilitate this group and will be held on Thursdays at 10:00 a.m. (start date TBD.) Fliers are being distributed widely. This group will be open to male and female victims of domestic violence, aged 55+.**

- **Anxiety/Stress/Self Care – Angie Williams will facilitate this new group. The group will meet on the 2nd Fridays of each month, beginning February 9, at 1:00 p.m. and 4th Friday of each month at 6:00 p.m., beginning February 23. It will address topics such as anxiety and stress in day to day life, as well as present healthy methods of coping and taking care of yourself, such as utilizing writing, art, and music as methods of de-stressing. You must be a current client of the domestic violence program in order to attend.**
- **DV 101 Group – Jared Bohland will facilitate this group, (start date TBD.) This group will follow an approximate 4 month curriculum, with set topics focused on the dynamics that surround domestic violence.**
- **Nutrition Group – Annette Lane will facilitate this group. This group begins on Friday, February 9.**

WNCF is located in the MAX office for MACON and DEWITT Counties. Below are the current Income Guidelines for Weatherization and Bill Payment Assistance. Families must show proof of income. A family's monthly gross income must fall between the ranges below, based upon family size, to qualify.

- Power must be on/ Bill must be current/no old bills
- No help from DMCOG/LiHeap/Pipp in the last twelve months
- Must meet income guidelines
- Must have proof of hardship and 60 days of paystubs

Family Size 30-Day (Gross) Monthly
Income Range Must be between:

1	\$1,508 - \$3,016
2	\$2,030 - \$4,060
3	\$2,533 - \$5,106
4	\$3,075 - \$6,150
5	\$3,598 - \$7,196
