# NEWS

from the Domestic Violence Program

The program has been through many challenges in the last few months, as a result of being without significant funding because of a lack of a State Budget. But through it all, the Shelter has remained open and staff and volunteers daily worked to meet those challenges.

We were in a position where we did have to cancel one of our weekly domestic violence support groups. Staff have continued to work additional hours in order to comply with our 24-hour Shelter coverage. Since Dove has been in a hiring freeze, we have been without a 2<sup>nd</sup> Shift Shelter Specialist, as well as a full-time Children's Specialist - staff who cover the weeknights and the 8-hour day shift on Saturdays.

But now, I am happy and very thrilled to report that a VOCA (Victims of Crime Act) Grant, that we submitted proposal for in early June, will be awarded! This will allow for us to replace these two staff positions and to begin to fill the positions needed to provide the services our clients need.

Soon we will be hiring a full-time Multi-County Advocate, additional Shelter Specialists, and two contractual Domestic Violence Trainers.

Staff have gone above and beyond during these challenging times – even while we were without air conditioning in the Shelter for a period of 3 weeks! Clients and staff pulled together and literally “weathered” the storm! This occurred during the some of the hottest days of the year!

A big thank you to the Salvation Army who loaned us several cots for our clients to sleep on, as we even had to move our Shelter residents downstairs to our Dean Simcox Conference Room in order to stay cool.

We also are grateful to One Source and Sunbelt Rentals who loaned us the portable air units. These were helpful and much appreciated!

Thankfully, work has been completed and it has cooled off in our Shelter. Times like this sure do make one appreciate things that we so often take for granted and to appreciate the wonderful staff and volunteers we get to work with each day.

## VOLUNTEER AND EDUCATION OPPORTUNITIES
