#### **Dove's Mission**

Dove is an organization that engages religious institutions, volunteers, and advocates seeking to coordinate efforts to address unmet needs and social injustices. These needs are met through coordinated programs focusing on domestic violence, homelessness, education, volunteer and community empowerment, and individual emergency need fulfillment.

Dove works for justice, equality, and understanding among all people.

### A Week in the Life of a Domestic Violence Survivor

At 2:30 a.m. on Monday, Police officers respond to a 911 call from neighbors to find "Cara" beaten and strangled by her partner. Her two small children witnessed everything. An ambulance transports Cara to the hospital for treatment. With her home destroyed and partner still at large, it is not safe for Cara and the children to return home. Police and hospital staff help Cara contact Dove Domestic Violence Program's Crisis Hotline to make shelter arrangements for the family. An officer transports Cara and her children to Dove's shelter. The Shelter Advocate welcomes the family and takes them to a prepared bedroom where they collapse, exhausted. Later that morning, a staff member helps Cara and the children with breakfast and then introduces the family to the Children's Advocate, who plays with the children while Cara completes intake and talks to staff about the abuse by her partner. She indicates she is ready to get out of the relationship and protect herself and her children. A Legal Advocate helps Cara complete paperwork for an Order of Protection and explains the protections offered.

On Tuesday, the Legal Advocate accompanies Cara to court and an Emergency Order of Protection is granted by the judge. That afternoon, Cara has her first meeting with her personal Advocate, who listens, validates her experiences and feelings, and works with her to create a service plan that focuses on independence and healing. The Advocate assists Cara with referrals to Dove Homeward Bound for housing, as well as to other local service providers. The Advocate explains Dove services and encourages Cara to take time for self-care and nurturing for her children. In the evening, Cara drops her children off in the playroom for Domestic Violence Children's Group, where the children learn about healthy relationships through fun activities and play. Cara attends Domestic Violence Support Group, where she receives support and understanding from other survivors.

On Wednesday morning, Cara attends Healthy Families Parenting Class and DV 101 Group to gain support and information on domestic violence. That afternoon, she meets again with her Advocate to talk about how she is feeling. On Thursday, Dove's Victim Advocate notifies Cara that her partner has been arrested and the Order of Protection has been served. Cara

feels a sense of validation and relief. On Friday, Cara tells her Advocate she feels safe enough to return to work and for the children to return to school. The Advocate helps Cara contact her employer and the school to explain the Order of Protection and do safety planning for the family. Although she still has a long way to go before complete independence and healing, Cara feels hopeful and supported in a way she has never experienced before.

Cara's story continues onward for several months as she obtains housing, continues counseling, and testifies in her partner's criminal case. Dove continues to provide support to Cara and her children as they move toward healing and autonomy.

---In reality, Cara is fictitious – a composite of stories from many of Dove's program participants – because sharing a survivor's true story and identity could put them in grave danger. However, the shelter itself, the services offered, the Dove staff members, the police officers, and hospital staff are all very real and work 24-hours-a-day to provide hope and safety for those experiencing domestic violence. Everyone in this story is a HERO! It took immense courage for Cara to take steps to leave an abusive relationship and those who helped her dedicated their lives to saving people like Cara and her children. You are a hero in Cara's story, too. Your support of Dove, Inc. keeps the shelter and Domestic Violence Program running, so that help is always available. Thank you!

October is Domestic Violence Awareness Month. We hope that you will join us at one of our Candlelighting Services in DeWitt, Macon, Moultrie, and Shelby Counties.

### The Importance of Domestic Violence Awareness Month

October marks Domestic Violence Awareness Month (DVAM), a time dedicated to raising awareness about the devastating impact of domestic violence and mobilizing communities to support victims and survivors. This month-long initiative serves as a critical opportunity to educate the public, challenge stigmas, and foster change. Domestic violence, which includes physical, sexual, emotional, psychological, and financial abuse, affects millions of people worldwide, regardless of gender, age, race, or socioeconomic status. Domestic Violence Awareness Month plays a crucial role in addressing this pressing issue and supporting those affected by it.

Domestic violence is not confined to physical harm; it can manifest as emotional manipulation, financial control, and isolation. It's a pattern of behavior aimed at gaining power and control over an intimate partner. According to the National Coalition Against Domestic Violence (NCADV), approximately 1 in 4 women and 1 in 9 men experience severe intimate partner violence, sexual violence, or stalking at some point in their lives. These staggering statistics reveal the extent of the problem and emphasize the need for sustained awareness.

While anyone can be a victim, certain populations are disproportionately affected. Women, LGBTQ+ individuals, and marginalized communities often face higher rates of abuse and greater barriers to accessing support. Recognizing this diversity in experiences is essential in creating inclusive resources and support systems.

Dove has and always will be an organization that believes in meeting the needs of everyone affected by domestic violence. Our mission is not only to help those who are affected but to educate our friends, family, and community.

As the calendar rolls over from September to October, our attention here in Shelby County turns to our annual Candlelight service. In actuality, a lot of our attention in September has been focused on preparation. We had our final CADV Candlelight meeting on September 12. I appeared on our local radio station to publicize our event on September 20 and met the preceding day with our local news reporter for a story in the Shelbyville Eagle. Much of my time when not meeting with participants has been spent on Candlelight.Our ceremony will be held on Thursday, October 3, 2024, at 7:00 p.m. at First Assembly of God Church, 108 South Oak, Shelbyville. The church is located at the corner of Illinois Route 16 and Oak Street.

Other than Candlelight, September was business as usual. Our local justice system continues to improve with our new State's Attorney and staff. Order of Protection numbers also continue to increase. September 10 saw the sentencing hearing for a 2019 domestic violence murder here in Shelbyville as the perpetrator was

sentenced to a lengthy prison term via a plea bargain negotiated by a Special Prosecutor assigned to the case by our former SA.

I have continued working closely with our local ROSC Council and our local Salvation Army. Salvation Army Bell Ringing season will be here soon; we are actively looking for bell ringers for the upcoming holiday season. I attended three trainings so far this month:

Child Abuse and Mandated Reporting provided by PCA Illinois and DCFS; ICADV's quarterly Diversity, Equity, and Inclusion training; and Trauma Training by Crossings Healthcare at our September staff meeting.
